S.K.H. Chan Young Secondary School Guidelines for 2026-27 S.1 Discretionary Places Application

Eligibility

Primary 6 students in academic year 2025-26 are welcome to apply. According to the guidelines from Education Bureau (EDB), applications for discretionary places (DP) are not subject to restrictions on districts. Students can apply to at most two participating secondary schools. Otherwise, the applications will be rendered void.

Candidates should hold a Hong Kong Identity Card or have the right to receive basic education according to the prevailing policy of the Hong Kong government. They should got grade B or above in conduct, and attaining 1A, 2B or above in Chinese, English, and Mathematics in either the second term exam of Primary 5 or the first term exam of Primary 6. If the results are presented in percentages, A is equivalent to 85% or above, and B is equivalent to 75% or above.

Number of Discretionary Places

The school has a total of 41 Discretionary Places for S.1.

Selection Criteria

Academic performance: 60%, Conduct: 10%, Interview performance: 30% Priority will be given to applicants with outstanding performance in extracurricular activities.

Application Procedures

Application forms shall be obtained from the General Office in person or downloaded from the school website (https://www.skhcyss.edu.hk/) from 1 December 2025 (Monday). Applicants are requested to submit the following for their applications from 2 January 2026 (Friday) to 16 January 2026 (Friday):

- 1. Application Form for Secondary One Discretionary Places from the EDB (On the EDB's copy, school's copy and parent's copy, the "Name of school applied" should have been filled in with "S.K.H. CHAN YOUNG SECONDARY SCHOOL".)
- 2. Completed Application Form of our school (with photo affixed)
- 3. A copy of Primary 5 (whole year) and Primary 6 (first term) report cards
- 4. A copy of certificate(s)/award record(s) listed in "Record of Major Achievements"

The General Office will be open from 8:30 a.m. – 5:00 p.m. on weekdays, and 9:00 a.m. – 1:00 p.m. on Saturdays. It will be closed on Sunday and public holidays.

Parents can submit the application forms and documents in person or by their authorized representatives to the school. Parents with "iAM Smart+" accounts may submit their application forms and documents through EDB's SSPA e-Platform. Submission of applications by postal mail or courier will not be accepted. Parents who use the SSPA e-Platform must ensure that all the required information and documents are successfully uploaded, otherwise applications will be deemed void.

S.1 Admission Interview

- 1. All applicants who have met the admission eligibility will be interviewed. They will be notified about the interview arrangements on or before Monday, 2 March 2026 by email.
- 2. Interviews will be held on Saturday, 14 March 2026. Applicants who are unable to attend the interview at the designated time may submit a written request in advance for rescheduling. Consideration will be made on a case-by-case basis.
- 3. The interview, including English conversations, communicating with the interviewers and group discussion, will be conducted in both English and Cantonese. If necessary, applicants may choose to answer in Putonghua.
- 4. The manners, language abilities, communication skills, analytical skills, etc. of the applicants will be assessed.

Result announcements

Successful applicants will be notified by email and phone on Tuesday, 31 March 2026. Applicants on the reserve list and unsuccessful applicants will not be notified. Official results will be released with the SSPA results on Tuesday, 7 July 2026.
